## Re: 2016 Operating Budget for the Lulu Island Energy Company

#### Origin

The 2016 Operating Budget for the Lulu Island Energy Company (LIEC) has been prepared by management and approved by the Corporation's Board of Directors. LIEC is providing its annual budget report to Council for information.

### Background

LIEC, a corporation wholly-owned by the City of Richmond, was established to provide district energy services for the City. Under direction from Council, and following receipt of the necessary approval from the Inspector of Municipalities, the incorporation of LIEC was completed in August 2013.

In June 2014, the City and LIEC executed a District Energy Utilities Agreement, assigning LIEC the function of establishing and operating district energy systems as well as providing thermal energy services on behalf of the City.

In October 2014, LIEC and Corix Utilities executed a Concession Agreement whereby LIEC would own the Oval Village District Energy Utility's (OVDEU) infrastructure, and Corix would design, construct, finance, operate and maintain OVDEU, subject to the City, as shareholder of LIEC, setting rates for customers and defining service areas.

## Analysis

OVDEU is the first district energy project developed under the oversight of LIEC. Staff are working with Corix on the successful delivery of Phase 1 of the OVDEU project; the first two connections (Onni's Riva 1 and Polygon's Carrera) and associated infrastructure were completed on time and under budget. Corix is continuing construction of the infrastructure necessary to connect more developments per LIEC's direction. The following table represents anticipated development connection timelines for the next two years:

The City of Richmond also owns and operates the Alexandra District Energy Utility (ADEU). LIEC was established as a separate legal entity for the purpose of operating and managing district energy utilities on the City's behalf, however, ADEU is currently not an asset of LIEC. Staff intend to bring forward a report with a recommendations to transfer ADEU assets and operations to LIEC in the current year. January 11, 2016

**Operating Budget** 

OVDEU is in its early stages of operation, and as a result its utility (electricity and natural gas), operation and maintenance costs are still largely based on projections of the financial model. In addition, the customers' energy use (building performance) is estimated based on the average building performance in the region and energy modeling reports prepared by the building designers. The 2016 Operating budget incorporates estimated revenues and expenses from the OVDEU based on the above projections and development activity. Over time, metered energy consumption and actual utility, operation and maintenance costs will be used to plan the budget.

In 2015, its first year of operations, LIEC's performance was better than budgeted with a larger than projected surplus; however staffing, overhead and other administration expenses were funded through assistance from the City as per the partnering agreement between the City and LIEC. District energy in Richmond was established on the basis that all capital and operating costs would be recovered through revenues from user fees, ensuring that the district energy utilities (DEU) are financially self-sustaining over the long term. Projected LIEC revenues for 2016 allow for some funding for administration and overhead to reduce the assistance from the City: an estimated 0.5 FTE staff was included in this year's budget as an Administration Fee recognizing staff's management of contracts and implementation support of OVDEU infrastructure and expansion, administration of City Centre North DEU development and LIEC;

overhead expense for City staff time recovery for billing, administration and IT support; an insurance expense in anticipation of ADEU asset transfer to LIEC; Professional Services Fees expense to include for the legal expenses for the ADEU assets transfer.

The 2016 operating budget is consistent with projections from the original business case for the Oval Village District Energy Utility and the LIEC.

## **Financial Impact**

None.

## Conclusion

The 2016 Operating budget has an overall budgeted net surplus of \$4,605, which will be transferred to a provision account to be used towards future capital repayments.
