In the year 2003, the City of Richmond sent me two tax statements, one of which was for 11800 Aztec Street property and the other one for 11660 Thorpe Road property. I was wondering about how they were mixed up and sent both tax statements on 11800 Aztec Street to my name instead of just one property at 11660 Thorpe Road. The Property on 11800 Aztec Street was already sold during the middle of 2002 and I owned only one house, not two, as the City of Richmond believes.

On June 26, 2003, while making the tax payment, I personally instructed the cashier to change my address to 11660 Thorpe Road, Richmond B.C V6X 1J6, as a permanent address for the 2004 Tax statement, as the other house on 11800 Aztec Street was already sold and transferred to a third party. She agreed and said the new statement would be forwarded to my new property at 11660 Thorpe Road.

I was waiting for the 2004 Tax Statement; unfortunately, I did not receive it until we visited the City of Richmond on July 05, 2004 to find out what had happened. Even the Utility Bill was not sent to my 11660 Thorpe Road address.

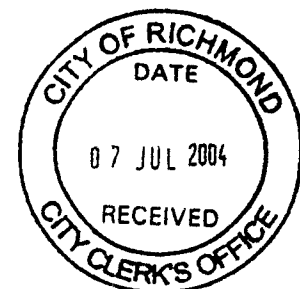
Under these circumstances, I strongly believe that it is the mistake of the City of Richmond and I am not liable for the 5% penalties for the City's mistake.

If you have any privacy concerns about how this information is used, contact the Home Owner Grant Administrative Branch at 250-256-8904, of the Ministry of Provincial Revenue (the "Branch").

(e) I am the spouse or relative of an owner who passed away in the current year who would have been eligible under paragraph (a), (b), (c), or (d) and I occupied an eligible residence as my principal residence on the date of that owner's death.

I understand that the collector, under the Branch may require any documentation necessary to establish my eligibility for the grant. I also understand that the Branch may confirm my age and address with the Insurance Corporation of British Columbia.

In response to Mrs. Fazal Syed's letter, I would like to present to Mayor and Council the following facts:

1. The property in question, 11660 Thorpe Road, was registered at Land Titles Office to Mr. & Mrs. Syed on December 17, 2002. At the time of registration, the mailing address to this property was 11800 Aztec Street. According to Land Titles, Mr. & Mrs. Syed also owned 11800 Aztec Street. Title did not change on this property until June 2nd, 2003.
2. When the City generated 2003 property tax bills in early May, the bills were sent to all property owners of record as of April 30th 2003. Since the Syeds were on title for both properties, they received a bill for each property.
3. City of Richmond cannot change mailing addresses for property owners. All requests for changes must be in made in writing and sent to BC Assessment for processing. When a request is made over the counter, staff will provide a change of address form for the property owner to complete. Completed forms will be forward to BC Assessment for their processing. In return, the City receives a monthly electronic file from BC Assessment to update our records. For the property in question, there were no instructions written on the homeowner grant received requesting an address change.
4. The City makes every effort to ensure that property owners are aware of the tax deadline. We advertise on local radio stations and the community newspaper of the impending due date. If the property owner has not received a bill, he is advised to contact the Tax Department immediately for another copy.

I hope this memo provides sufficient background information to the issues addressed in Mrs. Fazal Syed's letter.
