## Staff Report

## Origin

The U.B.C.M. which administers the Commercial Vehicle Licencing program has advised that a legislative change has been approved by the Provincial Government to amend the licence-year of commercial decals so that decals will be valid from January 1 and expire on December 31 in the year they are issued. This amendment comes into effect November 1, 2006.

#### **Analysis**

The current commercial vehicle licence-year is March 1 to the last day of February of the following year. The U.B.C.M reports that these dates have their roots in the old vehicle licence system when all vehicle licences expired on the last day of February and do not correspond with Municipal fiscal years and are inconvenient to the user groups.

Commercial Vehicle decals are regulated by the Provincial Government and distributed by participating municipalities. Any provincial amendments requires the City to amend the Commercial Vehicle Bylaw accordingly.

The bylaw also contains wording of Richmond's former title designation and outdated references to sections of the Municipal Act. It would be an appropriate time to update the bylaw to current wording and sections.


#### Conclusion

# Commercial Vehicle Licence Bylaw No. 4716, Amendment Bylaw 8145

The Council of the City of Richmond enacts as follows:

1. The Commercial Vehicle Licence Bylaw No. 4716 is amended at Part 1 by deleting the definitions of "Act" and "Licence-Year" and substituting the following definitions:

# "Act - means the Local Government Act, Chapter 323 of British Columbia"

"Licence-Year - means the period from January 1 to December 31"

- 2. The Commercial Vehicle Bylaw No. 4716 is amended by deleting the words "The Corporation of the Township of Richmond" where they appear in the bylaw and substituting the words "**The City of Richmond**".
- 3. The Commercial Vehicle Bylaw No 4716 is amended at Part 2 by deleting the words "Division 2 of Part 2" and substituting the words "**Division 3 of Part 20**"
- 4. This Bylaw is cited as "Commercial Vehicle Licence Bylaw No. 4716, Amendment Bylaw No. 8145
