

We are very pleased that our business has arrived at such a setting, and we intend to keep it this way.

We are planning to install a web-based security camera system to better monitor the entire premises 24 hours daily. It also can be used to help you to examine the going-ons' at the premises if you so choose.

Therefore, we would sincerely ask to council to kindly reconsider our case and allow Net Arena to re-open for business as soon as possible.
