Staff Report

Origin

Section 5.3 of the Business Licence Bylaw No. 7360 prescribes that a licenced business must comply with City bylaws as well as other applicable provincial and federal statutes, regulations, rules and orders:

5.3 Every licencee must comply with the requirements of this, or any other bylaw of the City, which governs or regulates the business for which such licence was granted, must comply with any requirements imposed by the Medical Health Officer, and must comply with all applicable statutes, regulations, rules, codes and orders of all federal or provincial authorities having jurisdiction of such business, and any person failing to comply with the requirements of this Part commits an offence and, upon conviction, is liable for the penalties specified.

Section 5.1 of the Business Licence Bylaw No. 7360 further provides that any failure to comply with paragraphs (a) to (e) of that section may result in the suspension, cancellation or revocation of a business licence. Section 5.2 of the Bylaw adds that Council may revoke or cancel a business licence:

5.1 Any licencee, operator, or any other person who:

(a) violates or contravenes any provision of this bylaw or a licence issued hereunder, or who causes or allows any provision of this bylaw or a licence issued hereunder to be violated or contravened; or

(b) fails to comply with any of the provisions of this bylaw or a licence issued hereunder; or

(c) neglects or refrains from doing anything required under the provisions of this bylaw, or a licence issued hereunder, or the Business Regulation Bylaw; or

(d) fails to maintain the standard of qualification required for the issuing of a licence under this bylaw; or

(e) makes any false or misleading statement,

commits an offence and upon conviction shall be liable to a fine of not more than Fifty Thousand Dollars (\$50,000.00), in addition to the costs of the prosecution, and where the offence is a continuing one, each day that the offence is continued shall constitute a separate offence, and may result in the suspension, cancellation or revocation of the licence in question.

5.2 Subject to the Local Government Act, Council may:

(a) revoke or cancel a licence issued under the provisions of this bylaw; and,

(b) refuse to grant the request of an applicant under this bylaw.

This report concerns contraventions of the *Food and Drugs Act*, R.S.C., 1985, c. F-27, as amended, and its associated Regulations (including the *Food and Drugs Regulations*, C.R.C., c. 870, as amended) and the failure to comply with the Business Licence Bylaw No. 7360 by Nagoya Trading Ltd., doing business as Tokyo Beauty at 4151 Hazelbridge Way, Unit 3660 and at 8191 Westminster Highway, Unit 120.

Analysis

Pursuant to s. 60(2) of the *Community Charter*, council may suspend or cancel a business for reasonable cause:

Business licence authority

60 (2) <u>In addition to the authority under section 15 (1) (e) [licences, permits and</u> <u>approvals — suspension and cancellation], a business licence may be suspended or</u> cancelled for reasonable cause.

(3) Before suspending or cancelling a business licence, the council must give the licence holder notice of the proposed action and an opportunity to be heard.

Authority to cancel a business licence is also set out in s.15(1)(e) of the *Community Charter* and section 5.2 of Business Licence Bylaw No. 7360 cited above:

Licensing and standards authority

15 (1) A council may, in regulating under this Act or the <u>Local Government Act</u>, provide for a system of licences, permits or approvals, including by doing one or more of the following:

(e) providing for the suspension or cancellation of licences, permits and approvals for

(i) failure to comply with a term or condition of a licence, permit or approval, or

(ii) failure to comply with the bylaw;

Reasons in support of the recommendation that the business licences be cancelled by Council are attached as Appendix "A" to this report for Council's consideration.

Financial Impact

Conclusion

Given that Nagoya Trading Ltd. was previously the subject of past Health Canada public health advisories for contraventions of federal legislation, and a Council business licence hearing and a subsequent 90 day business licence suspension¹, it is recommended that further action is required to protect public health and safety.

Based on the facts and for the reasons set out in Appendix "A" of this report, it is recommended that the business licence issued to Nagoya Trading Ltd for the Tokyo Beauty located and operating at 4151 Hazelbridge Way Unit 3660, be cancelled.

REASONS

<u>Facts</u>

- 1. The City of Richmond currently has three Tokyo Beauty businesses located within its boundaries at:
 - (i) 4151 Hazelbridge Way, Unit 3660
 - (ii) 8191 Westminster Highway, Unit 120, and
 - (iii) 6551 No 3 Road, Unit 1314.

Nagoya Trading Ltd.

- 2. Currently all 3 locations have business licences issued in the name of a corporation, Nagoya Trading Ltd., doing business as Tokyo Beauty. Appended as **Attachment 1** of these Reasons is a copy of the certificate of incorporation, the Notice of Articles, and a copy of a BC Company Search for Nagoya Trading Ltd.
- The business licence issued in the name of Nagoya Trading Ltd., for 4151 Hazelbridge Way, Unit 3660 was applied for on September 25, 2023 and was issued on October 31, 2023. Appended as Attachment 2 of these Reasons is a copy of the current business licence as well as a copy of the business licence application.
- 4. The business licence issued in the name of Nagoya Trading Ltd., for 8191 Westminster Highway, Unit 120 was applied for on September 25, 2023 and was issued on April 11, 2024. Appended as **Attachment 3** of these Reasons is a copy of the current business licence as well as copy of the business licence application.
- 5. The business licence in the name of Nagoya Trading Ltd., for 6551 No 3 Road, Unit 1314 was applied for on September 25, 2023 and was issued on October 31, 2023. Appended as **Attachment 4** of these Reasons is a copy of the current business licence as well as a copy of the business licence application.
- 6. According to the BC Company Search and the Notice of Articles and the business licence applications on file, the director identified for Nagoya Trading Ltd., is Zhou Zhu.
- 7. Immediately prior to September 25, 2023, all three Tokyo Beauty locations were operating under different corporate names.

JPCA Tokyo Beauty Ltd.

- 8. The business located at 4151 Hazelbridge Way, Unit 3660 was being conducted or carried on by JPCA Tokyo Beauty Ltd. The business licence was originally applied for on August 10, 2021 and issued on October 21, 2021. Appended as **Attachment 5** of these Reasons is a copy of the business licence issued to JPCA Tokyo Beauty Ltd., a copy of the business licence application made by JPCA Tokyo Beauty Ltd., as well as a copy of the certificate of incorporation, the Notice of Alteration, the Notice of Articles, the Certificate of Name Change, the Notice of Articles for JPCA Tokyo Beauty Ltd., and a BC Company Search for JPCA Tokyo Beauty Ltd. (Note, as shown from the documents set out in Attachment 5, JPCA Tokyo Beauty Ltd. was previously named 1178913 B.C. LTD., and BOLIWELL ENERGY SERVICES INC.)
- 9. According to BC Company Search, and the Notice of Articles, and the business licence application on file, the director identified for JPCA Tokyo Beauty Ltd., is Zhou Zhu.

JPCA International Market Ltd.

- 10. The business located at 8191 Westminster Highway, Unit 120 was being conducted or carried on by JPCA International Market Ltd. The business licence application was originally applied for on January 23, 2017 and issued on February 01, 2017. Appended as Attachment 6 of these Reasons is a copy of the business licence, a copy of the business licence application as well as a copy of the certificate of incorporation, the Notice of Articles and BC Company Search, for JPCA International Market Ltd.
- 11. According to corporate searches and certificates of incorporation and the business applications on file, the director and owner identified for JPCA International Market Ltd., is Zhou Zhu.
- 12. The business located at 6551 No 3 Road, Unit 1314 was being conducted or carried on by JPCA International Market Ltd. The business licence application was originally applied for on June 8, 2018 and issued on June 11, 2018. Appended as **Attachment 7** of these Reasons is a copy of the business licence and a copy of the business licence application.
- 13. According to BC Company Search, and the Notice of Articles and the business applications on file, the director identified for JPCA International Market Ltd., is Zhou Zhu.

14. Location maps showing the approximate locations of each of the three Tokyo Beauty locations is appended as **Attachment 8**.

Fifth Health Canada Public Advisory (March 27, 2024)

- 15. On March 27, 2024 a public health advisory was issued by Health Canada in respect of the business located at 4151 Hazelbridge Way, Unit 3660. Appended as **Attachment 9** is a copy of the March 27, 2024 public advisory issued by Health Canada.
- 16. The March 27, 2024 public health advisory listed several unauthorized health products seized from that location by Health Canada. These seized products are identified in the Health Canada public advisory as skin lightening and skin treatment products that are labeled to contain prescription, controlled, or over-the-counter drugs, which may pose serious health risks. These seized products from that location were also identified in the March 8, 2024 public health advisory issued by Health Canada that is appended as Attachment 10. These seized products were not authorized for sale by Health Canada and were being sold in contravention of the *Food and Drugs Act* and the *Food and Drug Regulations*.
- 17. The March 27, 2024 public health advisory states the following:
 - "Health Canada is advising about unauthorized health products for lightening skin or treating skin conditions (such as eczema or psoriasis) that may pose serious health risks."
 - "Authorized health products have an eight-digit Drug Identification Number (DIN), Natural Product Number (NPN) or Homeopathic Drug Number (DIN-HM)."
 - "Selling unauthorized health products in Canada is illegal."
 - "When Health Canada identifies unauthorized products that may pose serious health risks, Health Canada takes appropriate action to prevent further distribution and informs the public. This includes working with the Canada Border Services Agency to help prevent further importation of unauthorized products."

Fourth Health Canada Public Advisory (March 8, 2024)

- On March 8, 2024 a public health advisory was issued by Health Canada in respect of the Tokyo Beauty business located at 4151 Hazelbridge Way Unit 3660. Appended as Attachment 10 is a copy of the March 8, 2024 public advisory issued by Health Canada.
- 19. The March 8, 2024 public health advisory listed several unauthorized health products, which may pose a serious health risk, were seized from that location (i.e. 4151 Hazelbridge Way Unit 3660). These seized products were not authorized for sale by Health Canada and were being sold in contravention of the *Food and Drugs Act* and the *Food and Drug Regulations*.

- 20. The March 8, 2024 public advisory states the following:
 - "Update: March 8, 2024: Additional unauthorized health products seized from another Tokyo Beauty and Healthcare store in Richmond, B.C.

Further to its communication on September 18, 2023, Health Canada is warning consumers about additional unauthorized health products seized from another Tokyo Beauty and Healthcare store located at Unit 3660-4151 Hazelbridge Way, Richmond, B.C. These products are labelled to contain prescription, controlled, or over-the-counter drugs, and may pose serious health risks."

• "Selling unauthorized health products in Canada is illegal. Unauthorized health products have not been approved by Health Canada, which means that they have not been assessed for safety, efficacy and quality and may pose a range of serious health risks. For example, they could contain high-risk ingredients, such as prescription drugs, additives or contaminants that may or may not be listed on the label. These ingredients could interact with other medications and foods. In addition, these products may not actually contain the active ingredients that consumers would expect them to contain to help maintain and improve their health.

Prescription drugs should only be used under the advice or supervision of a health care professional because they are used to treat specific conditions and may cause serious side effects. Prescription drugs can only be legally sold to consumers in Canada with a prescription."

- "Read product labels to verify that health products have been authorized for sale by Health Canada. Authorized health products have an eight-digit Drug Identification Number (DIN), Natural Product Number (NPN) or Homeopathic Drug Number (DIN-HM)...."
- 21. The March 8, 2024 public advisory noted that the seized products included an unauthorized product, Pabron Gold A Granules Cold Medication that was already listed in a previous September 11, 2023 (updated on September 18, 2023) Health Canada public advisory issued in respect of the Tokyo Beauty business located at 8191 Westminster Highway Unit 120.
- 22. According to a recent, June 10, 2024 Health Canada advisory, Pabron Gold A is "a product sold without market authorization (DIN) in Canada. The Product is labelled to contain dihydrocodeine phosphate that is listed on Schedule I of the *Controlled Drugs and Substances Act*. The Product is labelled to contain guaifenesin, dl-methylephedrine hydrochloride, acetaminophen, chlorpheniramine maleate and caffeine that may pose a risk to health.". Appended as **Attachment 10A** is a copy of the June 10, 2024 Health Canada's Health product recall.

Third Health Canada Public Advisory (September 11, 2023, updated September 18, 2023)

- 23. On September 11, 2023, a public health advisory was issued by Health Canada in respect of the Tokyo Beauty business located at 8191 Westminster Highway Unit 120. Appended as **Attachment 11** is a copy of the September 11, 2023 public health advisory issued by Health Canada and updated on September 18, 2023.
- 24. The September 11, 2023, public health advisory (as updated on September 18, 2023) issued by Health Canada noted nine unauthorized products sold at 8191 Westminster Highway Unit 120 that were seized by Health Canada. These seized products were not authorized for sale by Health Canada and were being sold in contravention of the *Food and Drugs Act* and the *Food and Drug Regulations*.
- 25. The seized products were identified by the public advisory as being labelled to contain either prescribed, controlled or over-the-counter drugs that may pose serious health risks and one product was identified as containing Dihydrocodeine phosphate.

The Second Health Canada Public Advisory (March 31, 2021)

- 26. The second Health Canada public advisory being issued that related to a Tokyo Beauty location in Richmond was published on March 31, 2021 and involved Health Canada seizing several health products including eye drops, an eyewash and an acne gel from the Tokyo Beauty business located at 8191 Westminster Highway Unit 120, because they were unauthorized and may have posed serious health risks according to Health Canada. These seized products were not authorized for sale by Health Canada and were being sold in contravention of the *Food and Drugs Act* and the *Food and Drug Regulations*.
- 27. Appended as Attachment 12 is a copy of the March 31, 2021 public advisory issued by Health Canada.

The First Health Canada Public Health Advisory (February 15, 2019)

- 28. The first Health Canada public advisory being issued that related to a Tokyo Beauty location in Richmond was published on February 15, 2019. It was in respect of unauthorized products sold at the Tokyo Beauty business located at 8191 Westminster Highway, Unit 120. The products were seized by Health Canada and the products were identified by the public advisory as being labelled to contain a prescription drug that may pose serious health risks. These seized products were not authorized for sale by Health Canada and were being sold in contravention of the *Food and Drugs Act* and the *Food and Drug Regulations*.
- 29. Appended as Attachment 13 is a copy of the February 15, 2019 public advisory issued by Health Canada.

30. The February 15, 2019 public health advisory concerned the unauthorized product "Kobayashi Aibon/Eyebon Eyewash" which was labelled to contain a prescription drug (aminocaproic acid) which that advisory stated may pose serious health risks. Health Canada seized two formats, "Cool" and "Mild," from Tokyo Beauty & Health Care retail location in Richmond, British Columbia at 8191 Westminster Highway Unit 120.

Correspondence with Health Canada and Consequences of Contraventions

- 31. In addition to the evidence of contraventions of federal statutes and regulations and the documented seizures of contravening products that are documented in the public advisories issued by Health Canada that are appended as Attachments 9 to 13 of these Reasons, correspondence with representatives of Health Canada appended as Attachments 14 and 15 provide further details and particulars of the contraventions of federal statutes and regulations that include non-compliance with provisions of the *Food and Drugs Act*, R.S.C., 1985, c. F-27, as amended, and the *Food and Drug Regulations*, C.R.C., c. 870, as amended.
- 32. Only pharmaceutical products that have received a market authorization from Health Canada are approved for sale in Canada under the *Food and Drugs Act* and under the *Food and Drug Regulations*.
- 33. The selling of the unauthorized products by Nagoya Trading Ltd. (doing business as Tokyo Beauty), at 4151 Hazelbridge Way Unit 3660, and at 8191 Westminster Highway, Unit 120, in contravention of federal statutes and regulations and Health Canada requirements may have posed a serious risk to public health and safety.
- 34. Each and every contravention of federal statutes and associated Regulations described in the above and in the appended Attachments has put the pubic at risk by endangering public health and safety.

Findings/Determinations in Support of and Grounds for the Cancellation of the Business Licence

The following findings and determinations support and are grounds for the cancellation of the Business Licence issued to the Business Licence Holder for conducting or carrying on business from 4151 Hazelbridge Way, Unit 3660:

- 35. Section 5.3 of the Business Licence Bylaw No. 7360 prescribes that a licenced business must comply with City bylaws as well as other applicable provincial and federal statutes:
 - 5.3 Every licencee must comply with the requirements of this, or any other bylaw of the City, which governs or regulates the business for which such licence was granted, must comply with any requirements imposed by the Medical Health Officer, and must comply with all applicable statutes, regulations, rules, codes and orders of all federal or provincial authorities having jurisdiction of such

business, and any person failing to comply with the requirements of this Part commits an offence and, upon conviction, is liable for the penalties specified.

- 36. Section 5.1 of the Business Licence Bylaw No. 7360 further provides that any failure to comply with paragraphs (a) to (e) of that section may result in the suspension, cancellation or revocation of a business licence. Section 5.2 of the Business Licence Bylaw No. 7360 adds that Council may revoke or cancel a business licence:
 - 5.1 Any licencee, operator, or any other person who:

(a) violates or contravenes any provision of this bylaw or a licence issued hereunder, or who causes or allows any provision of this bylaw or a licence issued hereunder to be violated or contravened; or

(b) fails to comply with any of the provisions of this bylaw or a licence issued hereunder; or

(c) neglects or refrains from doing anything required under the provisions of this bylaw, or a licence issued hereunder, or the Business Regulation Bylaw; or

(d) fails to maintain the standard of qualification required for the issuing of a licence under this bylaw; or

(e) makes any false or misleading statement,

commits an offence and upon conviction shall be liable to a fine of not more than Fifty Thousand Dollars (\$50,000.00), in addition to the costs of the prosecution, and where the offence is a continuing one, each day that the offence is continued shall constitute a separate offence, and may result in the suspension, cancellation or revocation of the licence in question.

5.2 Subject to the Local Government Act, Council may:

(a) revoke or cancel a licence issued under the provisions of this bylaw; and,

- (b) refuse to grant the request of an applicant under this bylaw.
- 37. Pursuant to s. 60(2) of the *Community Charter*, council may suspend or cancel a business for reasonable cause:

Business licence authority

60 (2) In addition to the authority under section 15 (1) (e) [licences, permits and approvals — suspension and cancellation], a business licence may be suspended or cancelled for reasonable cause.

38. Authority to cancel a business licence is also set out in s.15(1)(e) of the *Community Charter* and section 5.2 of Business Licence Bylaw No. 7360 cited above:

Licensing and standards authority

15 (1) A council may, in regulating under this Act or the <u>Local Government Act</u>, provide for a system of licences, permits or approvals, including by doing one or more of the following:

(e) providing for the suspension or cancellation of licences, permits and approvals for

(i) failure to comply with a term or condition of a licence, permit or approval, or

(ii) failure to comply with the bylaw;

- 39. Each failure to comply with or contravention of the *Food and Drugs Act*, R.S.C., 1985, c. F-27, as amended, and its associated Regulations (including the *Food and Drug Regulations*, C.R.C., c. 870, as amended) by Nagoya Trading Ltd. (doing business as Tokyo Beauty) that is described above and that is documented in Attachments 9 to 13 (the public advisories issued by Health Canada and the seizures of offending products noted therein) and in Attachments 14 and 15 (the correspondence with representatives of Health Canada), has put the public at risk by endangering public health and safety.
- 40. Each instance of putting the public at risk by endangering public health and safety, is on its own or in combination with other instances, reasonable cause under s.60(2) of the *Community Charter* to cancel the business licence issued to:
 - (i) Nagoya Trading Ltd. (doing business as Tokyo Beauty), operating from 4151 Hazelbridge Way Unit 3660, Richmond, BC.
- 41. Each failure to comply with or contravention of the *Food and Drugs Act*, R.S.C., 1985, c. F-27, as amended, and its associated Regulations (including the *Food and Drug Regulations*, C.R.C., c. 870, as amended) by Nagoya Trading Ltd. (doing business as Tokyo Beauty) that is described above and that is documented in Attachments 9 to 13 (the public advisories issued by Health Canada and the seizures of offending products noted therein) and in Attachments 14 and 15 (the correspondence with representatives of Health Canada), is on its own or in combination with the other failures to comply or contraventions, is reasonable cause under s.60(2) of the *Community Charter* to cancel the business licence issued to:
 - (i) Nagoya Trading Ltd. (doing business as Tokyo Beauty), operating from 4151 Hazelbridge Way Unit 3660, Richmond, BC.
- 42. Moreover, each failure to comply with or contravention of the *Food and Drugs Act*, R.S.C., 1985, c. F-27, as amended, and its associated Regulations (including the *Food and Drug Regulations*, C.R.C., c. 870, as amended) by Nagoya Trading Ltd. (doing

business as Tokyo Beauty) that is described above and that is documented in **Attachments 9 to 13** (the public advisories issued by Health Canada and the seizures of offending products noted therein) and in **Attachments 14 and 15** (the correspondence with representatives of Health Canada), amounts to a failure to comply with the Business Licence Bylaw No. 7360 and, therefore, under the combined authority of s. 15(1)(e) of the *Community Charter* and Sections 5.1, 5.2 and 5.3 of the Business Licence Bylaw No. 7360, constitutes additional grounds to cancel the business licence issued to:

Background

Aminocaproic acid is a prescription drug used to decrease bleeding in various clinical situations. Aminocaproic acid has not been approved for topical use in Canada. Exposure to aminocaproic acid on the skin may affect the skin, and the drug may be absorbed through the skin into the blood. Side effects may include a general feeling of discomfort, muscle aches and pain, kidney damage, seizures, low blood pressure, slow heart beat, blood clots, and swelling caused by fluid build-up.

Betamethasone dipropionate, betamethasone valerate and clobetasol propionate are highly potent corticosteroid prescription drugs that are applied to the skin to treat inflammatory skin conditions. Side effects include skin irritation and, with prolonged use, skin weakening or deterioration. Adverse effects from using too much include decreased ability to fight infection, symptoms of adrenal gland suppression (i.e., low blood pressure, low blood sugar, weight loss, muscle pain, gastrointestinal problems and severe fatigue) or Cushing's syndrome (i.e., high blood pressure, high blood sugar, weight gain, muscle weakness, bone loss and severe fatigue), depending on how much has been absorbed. These drugs should not be used by pregnant or nursing people.

Dexamethasone is a prescription corticosteroid drug available in Canada as tablets, injections, and eye ointments, and is used to treat inflammatory conditions or to suppress the immune system. Dexamethasone as an ointment is not approved as an anti-itch medication. Side effects for topical corticosteroids include skin atrophy (thin and fragile skin with reduced elasticity), skin blood vessel changes (e.g., spider veins), skin colour changes, stretch marks, swelling, dry skin, burning sensations, local irritation, rashes, redness, itching, thinning hair or excessive hair growth, infections and allergic reactions. Topical corticosteroids absorbed through the skin may cause side effects throughout the body, especially when used over a large surface area and for a long time. This risk is greater in children, who may absorb proportionally larger amounts and be more susceptible to experiencing these side effects. Systemic side effects could include high blood pressure, high blood sugar, blurred vision, uneven heartbeats, weakness and swelling. Dexamethasone should not be used by people who are allergic to dexamethasone or to any ingredient in the formulation, people who have systemic fungal infections, or people who have received live virus vaccines. Dexamethasone is generally not recommended for use during pregnancy.

Erythromycin is an antibacterial prescription drug used for the prevention and treatment of specific infections. In topical format (applied to the skin), it is used in combination with another drug to treat moderate acne. Possible reactions include local skin irritation (peeling, itching, burning sensation, redness or tenderness) or other skin changes (change in colour, oiliness or swelling), inflammation, or irritation of the face, eyes and nose. Symptoms of a severe allergic reaction include swelling of the face, mouth, throat, lips and/or eyes, difficulty breathing, burning and/or painful red eyes, eye tearing and skin reactions (rashes, blisters and hives). Misuse or overuse could lead to bacteria growth that could become resistant to the antibiotic erythromycin, which means that treatment may not work in the future.

Hydroquinone is a prescription drug when it is greater than a 2% concentration and a natural health product at a concentration of 2% and under. It is used topically (applied to the skin) to lighten areas of darkened skin caused by different conditions (e.g., sun exposure, skin damage, pregnancy, medications or age). It should not be used by people who are allergic to hydroquinone or who are taking medicines that make their skin more sensitive to light. Hydroquinone is not recommended for pregnant or breastfeeding people, or for children. It should be used with caution in those who have previously had cancer. Side effects include skin reactions such as redness, dryness, cracked skin, burning, stinging, peeling, itching, increased sensitivity to sunlight, sunburn, blisters and scarring. It may cause skin discolouration (i.e., blue or black discolouration or white patches or spots) that, in some cases, can be disfiguring. In laboratory animals, it has been associated with cancer after long-term exposure.

Ibuprofen piconol 3% is a topical (applied to the skin) non-steroidal anti-inflammatory drug (NSAID) used to relieve burns. Health Canada has not approved any drugs containing ibuprofen for topical use. Ibuprofen absorbed through the skin may cause side effects throughout the body, especially when used over a large surface area and for a long time, or on damaged skin. Topical ibuprofen may cause serious side effects in people who are allergic to ibuprofen, aspirin or other NSAIDs, or who are asthmatic. Use of topical ibuprofen may also cause serious side effects such as stomach and intestinal bleeding, renal (kidney) dysfunction or failure, or cardiovascular dysfunction or failure in people who have problems with these organs. Topical ibuprofen can also cause serious side effects in people who are pregnant or breastfeeding, such as delayed and increased duration of labour.

Ketoconazole is a prescription antifungal drug typically used to treat skin and scalp infections. It should be used only under the supervision of a health care professional. When applied to skin, common side effects include severe irritation, itchiness and stinging. Contact dermatitis (an itchy or painful rash) and painful allergic reactions have been reported more rarely. Ketoconazole should not be used by pregnant or breastfeeding people unless directed by a health care professional.

Neomycin sulfate is an antibiotic prescription drug and should be used only under the supervision of a health care professional. Side effects include allergic reactions that range from mild skin reactions (itching, rash and hives) to severe, life-threatening allergic reactions (anaphylaxis). Side effects such as damage to nerve tissue or the central nervous system, inner ear, and organs responsible for hearing and balance, and reduced kidney function have occurred in patients taking neomycin orally (by mouth) or when applied on the skin to open wounds or damaged skin. As well, when not used as directed, neomycin sulphate could increase the risk of infections resistant to neomycin or other antibiotics. Neomycin sulphate should not be used by pregnant or breastfeeding people unless directed by a health care professional.

Penicillin potassium is an antibacterial prescription drug used for the prevention and treatment of specific infections. Penicillin has not been approved for use in ointments for topical use in Canada. Allergic reactions to penicillin may include swelling of the face, mouth, throat, lips, eyes, difficulty breathing and skin reactions (itchiness, flushing, hives), abdominal distress (cramping, nausea, vomiting or diarrhea) and low blood pressure. Serious and occasionally fatal hypersensitivity (anaphylactoid) reactions have been reported in patients receiving penicillin. Severe skin reactions that may also affect other organs have been reported in association with penicillin. Prolonged use of antibiotics may lead to yeast or fungal overgrowth. Misuse or overuse of penicillin may lead to the growth of bacteria that will not be killed by penicillin (resistance). This means that penicillin may not work in the future.

Prednisolone valerate acetate is a prescription corticosteroid drug available in Canada as eye drops used to treat inflammation of several parts of the eye. It has not been approved for use in creams or ointments in Canada. Common side effects for topical corticosteroids include skin atrophy (thin and fragile skin with reduced elasticity), skin blood vessel changes (e.g., spider veins), change in skin color, stretch marks, swelling, dry skin, burning sensation, local irritation, rash, redness, itching, thinning hair or excessive hair growth, infections and allergic reactions. Topical corticosteroids absorbed through the skin may cause side effects throughout the body, especially when used over a large surface area and for a long time. This risk is greater in children, who may absorb proportionally larger amounts and be more susceptible to side effects. Systemic side effects could include high blood pressure, high blood sugar, blurred vision, uneven heartbeats, weakness, and swelling. Prednisolone acetate should not be used in patients who are allergic to prednisolone acetate or to any ingredient in the formulation. Prednisolone acetate is not to be used in children and is not recommended for use during pregnancy or breastfeeding.

Tretinoin in topical format (applied to the skin) is a prescription drug used to treat acne. Topical tretinoin should not be used during pregnancy as it has been associated with birth defects. It should also not be used by those who are breastfeeding or by children under 12 years old, or by individuals who have inflamed or irritated skin, have a previous skin cancer or undiagnosed skin lesions, who are taking medicines that make their skin more sensitive to light, or who have an allergy to tretinoin. Tretinoin may cause pain, irritation, itchiness, redness, or swelling at the site of application. It may damage skin, change skin colour, and increase sensitivity to sunlight or tanning beds, causing sunburns. Using tretinoin in combination with hydroquinone may increase some of the side effects of tretinoin.

These products are labelled to contain prescription, controlled, or over-the-counter drugs, and may pose serious health risks.

The list of products seized has been added to the Affected Products table. Information on the health risks associated with these drugs as well as information for consumers can be found further below.

Original Advisory: September 18, 2023: Unauthorized health products seized from a Tokyo Beauty and Healthcare store in Richmond, B.C., may pose serious health risks

Health Canada is warning consumers about unauthorized health products it seized from a Tokyo Beauty and Healthcare store in Richmond, B.C. (120 - 8191 Westminster Highway). The products are labelled to contain prescription, controlled or over-the-counter drugs and may pose serious health risks.

Selling unauthorized health products in Canada is illegal. Unauthorized health products have not been approved by Health Canada, which means that they have not been assessed for safety, efficacy and quality and may pose a range of serious health risks. For example, they could contain high-risk ingredients, such as prescription drugs, additives or contaminants that may or may not be listed on the label. These ingredients could interact with other medications and foods. In addition, these products may not actually contain the active ingredients that consumers would expect them to contain to help maintain and improve their health.

Prescription drugs should only be used under the advice and supervision of a health care professional because they are used to treat specific conditions and may cause serious side effects. Prescription drugs can only be legally sold to consumers in Canada with a prescription.

Background

Aminocaproic acid is a prescription drug ingredient used to decrease bleeding in various clinical situations. Exposure to aminocaproic acid in the eye may affect the eye itself, and the acid may be absorbed through the tear ducts into the blood. Side effects may include watery eyes, vision changes, headache, dizziness, nausea, muscle weakness and skin rash.

Dihydrocodeine phosphate is a controlled substance regulated under the Controlled Drugs and Substances Act and is similar to the opioid codeine. Although codeine is approved in Canada, Health Canada has not authorized any drug products containing dihydrocodeine. Dihydrocodeine tablets are approved in certain countries for the relief of severe and chronic pain or as cough suppressants. Common adverse reactions include dizziness, headache, vertigo, visual disturbances, confusion, euphoria, nausea, and constipation. As with all opioids, use of dihydrocodeine may lead to drug dependence (addiction). Dihydrocodeine may cause slowed or stopped breathing, which can lead to severe drowsiness, unconsciousness, and death (opioid overdose). People with other medical conditions, including but not limited to those that affect the lungs, liver or kidney, may be at a higher risk of overdose. Children are more susceptible to overdose due to their smaller size. Dihydrocodeine should not be used by those who are pregnant or breastfeeding, or by those with an allergy to dihydrocodeine. Neostigmine methylsulfate is a prescription drug available in Canada as an injection used to prevent and treat urine retention and intestinal complications after surgery, to reverse the paralyzing effect of certain drugs used in surgery and in shock therapy, and to control symptoms of myasthenia gravis (a disease that causes weakness in the skeletal muscles). It has not been approved for use as eye drops in Canada. In the past, drugs similar to neostigmine were used to treat glaucoma, a group of eye diseases traditionally characterized by elevated pressure within the eye. These medications are no longer widely used because of the significant number of potential eye-related side effects, including blurred distance vision, frontal headaches, twitching lids, red eyes, cataracts (clouding of the normally clear lens of the eye), allergic reactions, iris cysts, retinal detachment with symptoms of reduced vision, sudden appearance of flashes of light or floaters that could lead to permanent vision loss, and the potential for causing a specific type of glaucoma attack with potential permanent vision loss. Prednisolone valerate acetate is a prescription corticosteroid drug available in Canada as eye drops used to treat inflammation of several parts of the eye. Systemic side effects could include high blood pressure, high blood sugar, blurred vision, uneven heartbeats, weakness, and swelling. Prednisolone acetate should not be used in patients who are allergic to prednisolone acetate or to any ingredient in the formulation. Prednisolone acetate is not to be used in children and is not recommended for use during pregnancy or breastfeeding.

Salicylic acid is a prescription drug when sold for topical uses at concentrations greater than 20% or with a certain level of acidity (pH less than 3.0) except when sold to be applied to warts, corns or calluses. It is also used to treat acne. It should not be used by people who are allergic to salicylic acid, by people with diabetes, poor circulation, loss of sensation in the extremities (e.g., hands and feet), or by children and teenagers with the flu or chicken pox (as it may increase the risk of Reye's syndrome, a serious disease that might lead to seizures and coma). It should not be used by pregnant or nursing people unless the area of exposure and duration of therapy is limited. Some products containing salicylic acid should not be used in children younger than two years of age. Salicylic acid can cause serious allergic reactions (hives, itching, trouble breathing, and swelling of the face, lips, or tongue), and severe skin irritation (redness, burning, dryness, itching, and peeling). It can also cause salicylate toxicity, a serious condition with nausea, vomiting, dizziness, loss of hearing, ringing in the ears, diarrhea, confusion, rapid breathing, and drowsiness. Side effects are more likely to occur in children and in people with kidney or liver disease, and with prolonged use over large areas. Salicylic acid should not be used on infected areas, on moles, birthmarks, warts with hair growing from them, or warts on the face.

CNCL - 74 (Special) **Ursodeoxycholic acid** is a prescription drug used for the management of cholestatic liver diseases (diseases that involve blocked or reduced bile flow from the liver). Serious side effects of taking ursodeoxycholic acid include allergic reactions, chest pain and difficulty breathing, stomach ache, nausea, diarrhea or constipation, swelling of the extremities (e.g., hands and feet), high blood pressure, fatigue, dizziness, headache, itchiness, fever and jaundice. Some patients have experienced additional symptoms such as vomiting and pain in the abdominal area caused by blockages in the gastrointestinal tract, which requires medical intervention. Blood tests are needed to monitor for the risk of liver toxicity from taking this drug. Ursodeoxycholic acid should not be used by people who have an allergy to ursodiol, have a blockage of bile flow due to liver or other disease, or by people who are pregnant, planning to become pregnant, or breastfeeding.

Prescription drugs should be taken only under the advice and supervision of a health care professional because of the risk of interactions with other medications and side effects. Prescription drugs can only be legally sold via a prescription.

Unauthorized health products have not been approved by Health Canada, which means that they have not been assessed for safety, effectiveness and quality and may pose serious health risks. They may contain ingredients, additives or contaminated ingredients not listed on the label. In addition, they may lack the active ingredients Canadians would expect them to contain to help maintain and improve their health or they may contain ingredients that could interact with other medications and foods. For all of these reasons, unauthorized health products could cause serious health effects. Selling unauthorized health products in Canada is illegal.

Some of the unauthorized health products are packaged and labelled in Japanese characters. As a result, information about ingredients, usage, dosage and side effects may not be understood by all consumers.

In addition, absorption into the nose via the tear duct may cause serious cardiac and respiratory side effects.

Issue

Health Canada is advising consumers that the unauthorized product "Kobayashi Aibon/Eyebon Eyewash" is labelled to contain a prescription drug (aminocaproic acid) and may pose serious health risks. The product is promoted as an eyewash for contact lens users and for the prevention of eye disease.

Health Canada seized two formats, "Cool" and "Mild," from a Tokyo Beauty & Health Care retail location in Richmond, British Columbia (120 - 8191 Westminster Highway).

Prescription drugs should be taken only under the advice and supervision of a healthcare professional because they are used in relation to specific diseases, and may cause serious side effects. The unauthorized health product was packaged and labelled in Japanese ("Eyebon" may also be translated as "Aibon"). As a result, information about ingredients, usage, dosage and side effects may not be understood by all consumers.

Selling unauthorized health products in Canada is illegal. Health Canada previously <u>warned</u> about this product after it was seized at a different retail store.

Products affected

- Kobayashi Aibon/Eyebon Eyewash Mild format

What you should do

- Stop using this product. Consult your health care professional if you have used this product and have health concerns.
- Read product labels to verify that health products have been authorized for sale by Health Canada. Authorized health
 products have an eight-digit Drug Identification Number (DIN), Natural Product Number (NPN) or Homeopathic Drug
 Number (DIN-HM). You can also check whether products have been authorized for sale by searching Health
 Canada's <u>Drug Product Database</u> and <u>Licensed Natural Health Product Database</u>.

Report any health product-related <u>adverse reactions</u> or <u>complaints</u> to Health Canada.

Who is affected

Consumers who have bought or used Kobayashi Aibon/Eyebon Eyewash products, in Cool and Mild formats.

Background

Aminocaproic acid is a prescription drug ingredient used to decrease bleeding in various clinical situations. Exposure to aminocaproic acid in the eye may affect the eye itself, and the acid may be absorbed through the tear ducts into the blood. Side effects may include watery eyes, vision changes, headache, dizziness, nausea, muscle weakness, and skin rash.

Unauthorized health products have not been approved by Health Canada, which means that they have not been assessed for safety, effectiveness and quality and may pose serious health risks. They may contain ingredients, additives or contaminated ingredients not listed on the label. In addition, they may lack the active ingredients Canadians would expect them to contain to help maintain and improve their health, or they may contain ingredients that may interact with other medications and foods. For all of these reasons, unauthorized health products could cause serious health effects.

Introduction

Before drug products are authorized for sale in Canada, Health Canada reviews them to assess their safety, efficacy and quality. Drug products include prescription and no-prescription pharmaceuticals, disinfectants and sanitizers with disinfectant claims. Prior to being given market authorization, a manufacturer must present substantive scientific evidence of a product's safety, efficacy and quality as required by the *Food and Drugs Act and Regulations*. When a product is offered for sale in Canada to treat or prevent diseases or symptoms, it is regulated as a drug under the *Food and Drugs Act*.

When Health Canada receives a new market authorization application of a natural health product, biologic or pharmaceutical drug, in addition to evaluating the data to determine whether the drug should be authorized for sale on the Canadian market, Health Canada also considers whether it is best sold as a prescription or non-prescription product. When Health Canada decides whether a drug should be prescription or nonprescription, it considers the three principles and their associated factors as they apply to a <u>particular drug</u>. If none of the principles and factors apply, then a drug will be a nonprescription product. Nonprescription products include natural health products, some biologics and some pharmaceutical drugs.

The three broad principles for determining prescription status are:

- Supervision by a practitioner is necessary
 - For the diagnosis, treatment, mitigation or prevention of a disease, disorder or abnormal physical state, or its symptoms, in respect of which the drug is intended to be used; or
 - To monitor the disease, disorder or abnormal physical state or its symptoms in respect of which the drug is intended to be used, or to monitor the use of the drug;
- The level of uncertainty respecting the drug, its use or its effects justifies supervision by a practitioner; or

 Use of the drug can cause harm to human or animal health or a risk to public health and the harm of risk can be mitigated by a practitioner's supervision

Drugs are typically given prescription status when their use may mask or hide other serious diseases in humans or animals. Where a drug masks other illnesses, and results in a lack of timely diagnosis and treatment; a significant worsening of the underlying disease; or otherwise putting at risk the chance of more successful therapy, the drug will likely be given prescription status. For example, if a person had problems with erectile function and could buy a product for erectile dysfunction without prescription, there would be a danger of this drug masking an underlying disease. Taking this drug might help the erectile dysfunction however, erectile dysfunction can be a symptom of conditions such as hypertension, coronary artery disease, high cholesterol or diabetes mellitus. Therefore, the person may think they are fine once on the drug, but they still could have one of these underlying conditions which can be fatal. One of the reasons erectile dysfunction drugs are prescription drugs is concern that these drugs could delay proper diagnosis which could have significant consequences for a patient.

The market authorization of drug products in Canada is in the form of a drug identification number (DIN). A DIN is an eight digit numerical code preceded by the prefix DIN which is assigned to each drug product marketed under or in accordance with the *Food and Drugs Act and Drug Regulations*. Drugs which have not been assigned a DIN are referred to as unapproved drugs.

The activities of manufacturing, packaging, labelling, testing, distributing, wholesaling and importation of drug products into Canada for the purpose of sale requires that the regulated party be issued a drug establishment license (DEL) for said activity. A DEL is issued to regulated parties to conduct licensable activities in a building which has been inspected and assessed as being in compliance with the *Food and Regulations*, including Good Manufacturing Practices. The importation, for sale or personal use, of prescription drugs is limited to the following:

- A practitioner;
- A drug manufacturer;
- A wholesale druggist;
- A pharmacist; or
- A resident of a foreign country while a visitor in Canada.

The sale of prescription drugs in Canada is restricted to either (i) those individuals that are entitled under the laws of a province to dispense a prescription drug and they sell it in that province under a verbal or written prescription that they received or (ii) a drug manufacturer, a practitioner, a wholesale druggist, a pharmacist, or the Government of Canada or the government of a province under a written order.

A drug is defined in the Food and Drugs Act (FDA) as:

Drug includes any substance or mixture of substances manufactured, sold or represented for use in

- (a) the diagnosis, treatment, mitigation or prevention of a disease, disorder or abnormal physical state, or its symptoms, in human beings or animals,
- (b) restoring, correcting or modifying organic functions in human beings or animals, or
- (c) disinfection in premises in which food is manufactured, prepared or kept

Relevant Section(s) of the Legislation

Food and Drugs Act (FDA) and Food and Drug Regulations (FDR) Section 9 of FDA

9 (1) No person shall label, package, treat, process, sell or advertise any drug in a manner that is false, misleading or deceptive or is likely to create an erroneous impression regarding its character, value, quantity, composition, merit or safety.

(2) A drug that is not labelled or packaged as required by, or is labelled or packaged contrary to, the regulations shall be deemed to be labelled or packaged contrary to subsection (1).

Section C.01.014 of FDR

C.01.014 (1) No manufacturer shall sell a drug in dosage form unless a drug identification number has been assigned for that drug and the assignment of the number has not been cancelled under section C.01.014.6.

Section C01.041 of FDR

C.01.041 (1) No person shall sell a prescription drug unless

(a) they are entitled under the laws of a province to dispense a prescription drug and they sell it in that province under a verbal or written prescription that they received; or

(b) they sell it under section C.01.043.

(2) In the case of a verbal prescription, the person referred to in paragraph (1)(a) or a pharmacy technician shall create a written record of the prescription that includes the following information:

(a) the date on which the prescription was received and, if applicable, the number of the prescription;

(b) the name and address of the person to whom the prescription was issued;

(c) the proper name, common name or brand name of the drug and its quantity;

(d) the person's name and the name of the practitioner who issued the prescription; and

(e) the directions for use provided with the prescription, whether or not the practitioner authorized it to be refilled and, if refills are authorized, the number of authorized refills.

(3) The person referred to in paragraph (1)(a) shall retain the written prescription referred to in subsection (1) or the record referred to in subsection (2) for at least two years after the day on which the prescription is filled.

Section C.01.043 of FDR

C.01.043 (1) A person may sell a prescription drug to

(a) a drug manufacturer

(b) a practitioner

(c) a wholesale druggist

(d) a pharmacist; or

(e) the government of Canada or the government of a province, for the use of a department or agency that government, on receipt of a written order signed by the minister responsible for the department or by the person in charge of the agency, or by their duly authorized representative.

(2) if a person sells a prescription drug under to the general public, the person shall not make any representation other than with respect to the brand name, the proper name, the common name and the price and quantity of the drug.

C.01.003 No person shall sell a drug that is not labelled as required by these Regulations.

C.01.004 (1) The inner and outer labels of a drug shall show

(a) on the principal display panel

(i) the proper name, if any, of the drug which, if there is a brand name for the drug, shall immediately precede or follow the brand name in type not less than one-half the size of that of the brand name,

(ii) if there is no proper name, the common name of the drug,

(b) on the upper left quarter of the principal display panel

(i) the symbol "Pr" in the case of a prescription drug, but the symbol "Pr" shall not appear on the label of any other drug,

(c) on any panel

(i) the name and address of the manufacturer of the drug,

(ii) the lot number of the drug,

(iii) adequate directions for use of the drug,

(iv) a quantitative list of the medicinal ingredients of the drug by their proper names or, if they have no proper names, by their common names,

(v) the expiration date of the drug, and

(2) In addition to the requirements of subsection (1) and, if applicable, subsections (1.1) to (1.4), the outer label of a drug must show all of the following information:

(a) the net amount of the drug in the container in terms of weight, measure or number;

(3) Where the container of a drug is too small to accommodate an inner label that conforms to the requirements of these Regulations, the inner label requirements of these Regulations do not apply to the drug in that container if (a) there is an outer label that complies with the labelling requirements of these Regulations; and

(b) the inner label shows

(i) the proper name of the drug, the common name of the drug if there is no proper name or, in the case of a drug with more than one medicinal ingredient, the brand name of the drug,

(ii) the potency of the drug except where, in the case of a drug with more than one medicinal ingredient, the name used pursuant to subparagraph (i) for that drug is unique for a particular potency of the drug,

(iii) the net contents of the drug if it is not in a discrete dosage form,

(iv) the route of administration of the drug if other than oral,

(v) the lot number of the drug,

(vi) the name of the manufacturer of the drug,

(vii) the expiration date of the drug, and

(viii) the identification of special characteristics of the dosage form if they are not evident from the name of the drug under subparagraphs (i) or (ii).

Section C.01A.004 of the FDR

C.01A.004 (1) Subject to subsection (2), no person shall, except in accordance with an establishment licence,

- (a) fabricate, package/label or import a drug;
- (b) perform the tests, including examinations, required under Division 2;
- (c) distribute as a distributor referred to in section C.01A.003 a drug other than
 - (i) an active pharmaceutical ingredient, or
 - (ii) an active ingredient that is used in the fabrication of a drug that is of non-biological origin and that is listed in Schedule C to the Act; or
- (d) wholesale a drug other than
 - (i) an active pharmaceutical ingredient, or
 - (ii) an active ingredient that is used in the fabrication of a drug that is of non-biological origin and that is listed in Schedule C to the Act.

Division 8 of the FDR - New Drugs

New Drugs

C.08.001 For the purposes of the Act and this Division, new drug means a drug, other than a veterinary health product,

- (a) that contains or consists of a substance, whether as an active or inactive ingredient, carrier, coating, excipient, menstruum or other component, that has not been sold as a drug in Canada for sufficient time and in sufficient quantity to establish in Canada the safety and effectiveness of that substance for use as a drug;
- (b) that is a combination of two or more drugs, with or without other ingredients, and that has not been sold in
 that combination or in the proportion in which those drugs are combined in that drug, for sufficient time and in
 sufficient quantity to establish in Canada the safety and effectiveness of that combination and proportion for
 use as a drug; or
- (c) with respect to which the manufacturer prescribes, recommends, proposes or claims a use as a drug, or a
 condition of use as a drug, including dosage, route of administration or duration of action, and that has not
 been sold for that use or condition of use in Canada for sufficient time and in sufficient quantity to establish in
 Canada the safety and effectiveness of that use or condition of use of that drug.

C.08.002 (1) No person shall sell or advertise a new drug unless

 (a) the manufacturer of the new drug has filed with the Minister a new drug submission, an extraordinary use new drug submission, an abbreviated new drug submission or an abbreviated extraordinary use new drug submission relating to the new drug that is satisfactory to the Minister;

- (b) the Minister has issued, under section C.08.004 or C.08.004.01, a notice of compliance to the manufacturer of the new drug in respect of the submission; and
- (c) the notice of compliance in respect of the submission has not been suspended under section C.08.006.

- G.01.005 (1) A person is authorized to possess a controlled drug set out in any of items 1 to 3, 8 to 10, 12 to 14, 16 and 17 of Part I of the schedule to this Part if the person has obtained the controlled drug in accordance with these Regulations, in the course of activities conducted in connection with the administration or enforcement of an Act or regulation, or from a person who is exempt under section 56 of the Act from the application of subsection 5(1) of the Act with respect to that controlled drug, and the person
 - o (a) requires the controlled drug for their business or profession and is
 - (i) a licensed dealer,
 - (ii) a pharmacist, or
 - (iii) a practitioner who is registered and entitled to practise in the province in which they possess that drug;
 - (b) is a practitioner who is registered and entitled to practise in a province other than the province in which they have that possession for emergency medical purposes only;
 - (c) is a hospital employee or a practitioner in a hospital;
 - o (d) has obtained the controlled drug for their own use
 - (i) from a practitioner, or

- (ii) in accordance with a prescription that was not issued or obtained in contravention of these Regulations;
- (e) is a practitioner of medicine who received the controlled drug under subsection G.06.003(1) or (2) and their possession is for the purpose of providing or delivering it to a person referred to in subsection G.06.003(3);
- (f) is an agent or mandatary of a practitioner of medicine who received the controlled drug under subsection G.06.003(1) and their possession is for the purpose of providing or delivering it to a person referred to in subsection G.06.003(2);
- (g) is employed as an inspector, a member of the Royal Canadian Mounted Police, a police constable, a peace officer or a member of the technical or scientific staff of the Government of Canada, the government of a province or a university in Canada and their possession is in connection with that employment;
- (h) is not a practitioner of medicine referred to in paragraph (e) or an agent or mandatary referred to in paragraph (f), is exempted under section 56 of the Act with respect to possession of that controlled drug and their possession is for a purpose set out in the exemption; or
- o (i) is the Minister.

We will be recommending for the business licence to be suspended for this location and want to make sure that we have information to provide to council regarding other agency actions. Any additional information would be appreciated.
