Staff Report

Origin

The City's Business Licencing department administers a licencing program for approximately 14,000 licence holders and regulates the activities of approximately 24 business types including therapeutic touch clinics. This report deals with the activities and bylaw infractions of 1015616 BC Ltd., doing business as Lucky Feet Reflexology Centre ("Lucky Feet"), operating from a premises located at 3086 St Edwards Drive Unit 103, Richmond BC.

Lucky Feet is licenced as a Therapeutic Touch Clinic and must adhere to all applicable bylaws, including Part Fourteen of Business Regulation Bylaw No. 7538 (Attachment 1). This business has come to the attention of the Chief Licence Inspector after several complaints regarding staying open later than the permitted hours (9:30 p.m. each day).

Findings of Fact

On November 21, 2014, a business licence was issued to Ping Lin to operate Lucky Feet. There was a compliance inspection prior to licence issuance, at which time the owner acknowledged that the business is required to close at 9:30 p.m.

On April 1, 2016, a complaint was made to Chief Licence Inspector regarding five therapeutic touch clinics operating beyond permitted hours. The complainant provided a statement and a receipt for service from Lucky Feet dated March 29, 2016 at a time of 10:37 p.m.

On April 5, 2016, the owner was contacted by phone and given a verbal warning about staying open beyond permitted hours; the owner denied being open past 9:30 p.m.

On April 6, 2016, a warning letter was written and mailed to Lucky Feet regarding their hours of operation (Attachment 2).

On August 10, 2016, another complaint was received that Lucky Feet continued to operate later than permitted hours.

On September 2, 2016, an inspection was performed at 10:37 p.m., at which time inspectors found the front door unlocked and massage services being performed to one client inside the premises. The client and staff both indicated that service was started at 9:50 p.m. and further that one hour of service was to be provided.

On September 22, 2016, the Chief Licence Inspector met with the owner of Lucky Feet, Ping Lin as well as her husband, Xian Zhen Zhao, to present a history of findings related to bylaw violations (Attachment 3). At the meeting, Ms. Lin and Mr. Zhao indicated that they stay open late occasionally when a client arrives late, or is unable to make it in time for an 8:30 pm. appointment. They further indicated that there is a lot of pressure to stay open late for fear of losing clients to other businesses. However, they apologized and verbally committed to adhering to the closing time regulation of 9:30 p.m.

CNCL - 5 (Special)

Analysis

Business Regulation Bylaw No. 7538, Part Fourteen: Therapeutic Touch Clinic Regulation, permits therapeutic touch clinics to operate between 8:00 a.m. and 9:30 p.m. This regulation provides equity among different clinics and balances neighbourhood impact with the public demand for services to provide equity among businesses and to mitigate potential impact on the adjacent community. Lucky Feet's business operations provided them an unfair competitive advantage over business operators within the same business classification.

Lucky Feet was issued a verbal and written warning prior to an inspection which found one client in the premises beyond regulated operating hours. While the owner was apologetic, the verbal and written warnings were not sufficient to stop the practice of operating beyond permitted hours.

Given the degree of severity of the infractions, it is the recommendation of the Chief Licence Inspector that the business licence for 1015616 BC Ltd., doing business as Lucky Feet Reflexology Centre, be suspended for 3 days following Council's consideration of this report. Suspension of the licence is warranted by Part 23.1 of Business Regulation Bylaw No. 7538 for failing to comply with sections 14.1.1 (b).

Financial Impact

None.

Conclusion

Therapeutic touch clinics are regulated businesses under Business Regulation Bylaw No. 7538 and are permitted to operate only between the hours of 8:00 a.m. and 9:30 p.m. Lucky Feet's repeated violation of this bylaw warrants business licence discipline as recommended.

PART FOURTEEN: THERAPEUTIC TOUCH CLINIC REGULATION

14.1 Operator Obligations

14.1.1 Every Therapeutic Touch Clinic operator must:

- (a) provide the Licence Inspector with 24 hours' written notice of any changes in the personnel employed or engaged in such business, and the applicable provisions of the Business Licence Bylaw apply to any new persons proposed to be employed or engaged by the said Therapeutic Touch Clinic;
- (b) permit such business to be open only between the hours of 8:00 a.m. and 9:30 p.m. each day; and
- (c) provide the **Licence Inspector** with the name, age, birthdate, current address and picture identification of every **person** proposed to be employed or engaged in such **business**, together with such additional information which the **Licence Inspector** may require.

Lucky Feet Reflexology Centre is one of the businesses complainant states is violating hours of operation. Complainant provides statement to DUARTE and provides a list and receipt for service received from Lucky Feet Reflexology Centre on March 29, 2016, with a time of 22:37 hrs. – Copy of list – Attachment 2, Copy of Notes – Attachment 3, Copy of Receipt – Attachment 4

April 05, 2016 – 14:06 hrs – DUARTE contacts LIN regarding complaint received on their business operating outside permitted hours. LIN denies operating past 9:30 p.m. and states they close at 9:30 p.m. DUARTE instructs LIN that DUARTE has a witness that has provided a receipt with clear time and date stamp which shows business operated until 10:37 p.m., over one hour from when business was required to be closed. DUARTE informed LIN that DUARTE's witness was prepared to go to Provincial Court to testify if required. DUARTE informs LIN DUARTE should not be hearing denials, but rather that it will not happen again. LIN Warned that further violatations could result in fines, suspension or cancellation of her business licence. Staff Report

Origin

The City's Business Licencing department administers a licencing program for approximately 14,000 licence holders and regulates the activities of approximately 24 business types including therapeutic touch clinics. This report deals with the activities and bylaw infractions of Jin Ming Che, Zhi Hong Chen and Xiao Ji Lui, doing business as Marco Health Centre, operating from a premises located at 4400 Hazelbridge Way Unit 100, Richmond BC.

Marco Health Centre is licenced as a therapeutic touch clinic and must adhere to all applicable bylaws, including Part Fourteen of Business Regulation Bylaw No. 7538 (Attachment 1). This business has come to the attention of the Chief Licence Inspector after several complaints regarding staying open later than the permitted hours (9:30 p.m. each day).

Findings of Fact

In July 2015, a business licence was approved and issued for Marco Health Centre to begin operation.

On March 14, 2016, a complaint was received on a number of therapeutic touch clinics, including Marco Health Centre, for operating outside permitted hours. As a result of this complaint, a licence inspector left several telephone message with the owners of the business.

On April 1, 2016, another complaint was received and the complainant provided a statement and a receipt for service from Marco Health Centre dated March 30, 2016 at a time of 10:13 p.m.

On April 1, 2016, Ling Yun Guo, a spouse of one of the business owners, attended Richmond City Hall to speak with a licence inspector on behalf of Marco Health Centre. Ms. Guo indicated to the licence inspector that she was aware of the permitted operating hours but that clients are offered a full hour of service as long as they arrive before 9:30 p.m. Ms. Guo was instructed that if a full hour of service is to be offered then those appointments must start no later than 8:30 p.m. Ms. Guo states that she understood and that she would inform her husband and his partners.

On April 5, 2016, a letter of warning is mailed to the owners of Marco Health Centre.

On August 10, 2016, another complaint was received that Marco Health Centre continued to operate later than permitted hours.

On September 2, 2016, an inspection was performed at 10:00 p.m., at which time inspectors found the front door unlocked and massage services being performed to three clients. Three staff were also on the premises, two of which identified themselves as owners.

On September 25, 2016, the Chief Licence Inspector met with Ms. Guo, as well as her husband, Jin Ming Che who is one of the owners of Marco Health Centre. At the meeting, the history of complaints and inspections was presented to both Ms. Guo and Mr. Che (Attachment 3). At the meeting, Ms. Guo and Mr. Che indicated that they stay open late because customers often arrive late for their appointments and refuse to shorten their appointments such that the business can be

closed by 9:30 p.m. They further indicated that many other businesses stay open late and they are trying to remain competitive. They also stated that they do not accept walk-ins after 8:30 p.m. but they will provide services for those that have an appointment. Although an English-Chinese translator was provided for Mr. Che (who indicated he did not speak English), most of the information during the meeting was provided, in English, from Ms. Guo.

Analysis

Business Regulation Bylaw No. 7538, Part Fourteen: Therapeutic Touch Clinic Regulation, permits therapeutic touch clinics to open between 8:00 a.m. and 9:30 p.m. This regulation provides equity among different clinics and balances neighbourhood impact with the public demand for services to provide equity among businesses and to mitigate potential impact on the adjacent community. Marco Health Centre's business operations provided them an unfair competitive advantage over business operators within the same business classification.

Marco Health Centre was issued a verbal and written warning prior to an inspection which found three clients in the premises beyond regulated operating hours. Unlike other businesses spoken to during the investigation, a representative for the owner did not offer a firm commitment to conform to the regulations.

Given the degree of severity of the infractions and uncertainty regarding future compliance, it is the recommendation of the Chief Licence Inspector that the business licence for Jin Ming Che, Zhi Hong Chen and Xiao Ji Lui, doing business as Marco Health Centre, be suspended for 7 days following Council's consideration of this report. Suspension of the licence is warranted by Part 23.1 of the Business Regulation Bylaw No. 7538 for failing to comply with sections 14.1.1 (b).

Financial Impact

None.

Conclusion

Therapeutic touch clinics are regulated businesses under Business Regulation Bylaw No. 7538 and are permitted to operate only between the hours of 8:00 a.m. and 9:30 p.m. Marco Health Centre's repeated violation of this bylaw warrants business licence discipline as recommended.



Origin

The City's Business Licencing Division administers a licencing program for approximately 14,000 licence holders and regulates the activities of approximately 24 business types including therapeutic touch clinics. This report deals with the activities and bylaw infractions of A & K Health Enterprises Ltd., doing business as King Feet Massage ("King Feet"), operating from a premises located at 4940 No. 3 Road Unit 132, Richmond BC.

King Feet is licenced as a therapeutic touch clinic and must adhere to all applicable bylaws, including Part Fourteen of Business Regulation Bylaw No. 7538 (Attachment 1). This business has come to the attention of the Chief Licence Inspector after several complaints regarding staying open later than the permitted hours (9:30 p.m. each day).

Findings of Fact

On February 8, 2013, a complaint was received regarding operating outside permitted hours and a licence inspector followed up with Pui Sze (Eugenia) Chan regarding the complaint. At the time of this complaint, Ms. Chan identified herself as the manager of the business.

On March 14, 2016, a complaint was received on a number of therapeutic touch clinics, including King Feet, for operating outside permitted hours. An inspector spoke with Ms. Chan about the complaint and reminded her that she was previously warned about the same complaint.

On March 30, 2016, as a result of an application for change of ownership, Ms. Chan was again reminded about permitted operating hours. Ms. Chan confirmed she is aware of the regulations.

On April 1, 2016, another complaint was received and the complainant provided a statement and a receipt for service from King Feet dated March 26, 2016 at a time of 10:37 p.m.

On April 5, 2016, Ms. Chan attended City Hall to meet with a licence inspector to discuss complaints made for operating outside of permitted hours. At the meeting, Ms. Chan was provided with a copy of the receipt and informed the licence inspector that she was unaware that her staff were working late. Ms. Chan was issued a Municipal Ticket Information (MTI) BL 06671, which included a \$100 fine. The meeting was followed up with a warning letter mailed to the business regarding hours of operation (Attachment 2).

On August 10, 2016, another complaint was received that King Feet continued to operate later than permitted hours.

On September 2, 2016, inspection of the business is performed at 10:08 p.m., at which time inspectors find the doors locked, but a staff member offers to let the inspectors inside and provided an offer of massage services. During the inspection, the inspectors observe 11 customers and 9 staff inside the business.

On September 30, 2016, the Chief Licence Inspector met with Ms. Chan, as well as her legal counsel, Steve Lam, to present the history of findings related to bylaw violations at King Feet. At the meeting, Mr. Lam explained that Ms. Chan has been taking a leave from the business for the last 10 months to

care for her newborn baby at home and has left operation of the business in the hands of her managers. Upon receipt of the complaints in March, April and August, Ms. Chan did not take any action with the manager or with the staff other than asking the employees to return their keys. Subsequent to the inspection in September, the night manager has been moved to the morning shift and Ms. Chan has resumed supervision of the business for the closing time. In discussion regarding a potential suspension of the business licence, Chan indicated that any suspension would be harmful to her business.

Analysis

Business Regulation Bylaw No. 7538, Part Fourteen: Therapeutic Touch Clinic Regulation, permits therapeutic touch clinics to operate between 8:00 a.m. and 9:30 p.m. This regulation provides equity among different clinics and balances neighbourhood impact with the public demand for services to provide equity among businesses and to mitigate potential impact on the adjacent community. King Feet's business operations provided them an unfair competitive advantage over business operators within the same business classification.

King Feet was issued several verbal warnings, an MTI fine and a written warning prior to an inspection which found 11 clients in the premises beyond permitted operating hours. During the inspection (which occurred after 10 p.m.), there was no indication that the business was even in the process of closing, evidenced by one of the inspectors being offered an appointment at that time. While the owner has stated that they have now taken action to conform to the regulations in the bylaw, there was no substantial action taken as a result of the previous warnings.

Given the degree of severity of the infractions, it is the recommendation of the Chief Licence Inspector that the business licence for A & K Health Enterprises Ltd., doing business as King Feet Massage, be suspended for 10 days. Suspension of the licence is warranted by Part 23.1 of Business Regulation Bylaw No. 7538 for failing to comply with section 14.1.1 (b).

Financial Impact

None.

Conclusion

Therapeutic touch clinics are regulated businesses under the Business Regulation Bylaw and are permitted to operate only between the hours of 8:00 a.m. and 9:30 p.m. King Feet's ongoing and repeated violation of this bylaw warrants business licence discipline as recommended.




